SJS KidsCare is a program of St. James/Seton Catholic School. SJS KidsCare is under the direction of the St. James/Seton Catholic School Principal/Director, and the SJS KidsCare/Manager. As is the case of all school programs and functions, all elements of the SJS KidsCare program are under the general guidance and direction of the SJS School Administration to include the Pastors of St. James Parish and St. Elizabeth Ann Seton Parish. The SJS Total Board of Education will act as an Advisory Committee and assist with policies and/or questions.

SJS KidsCare is a school aged childcare program offered to families with students in grades K-8 at St. James/Seton Catholic School. Care is offered before school (7:00 a.m. – 7:40 a.m.) and after school (3:15 p.m. – 6:00 p.m.), when school is in session. This does include 1:20 pm dismissal days. Limited child-care services will be provided on the days when the school is not in session. SJS KidsCare **will not be open** during the Thanksgiving, Christmas, or Easter breaks nor will services be provided on snow days. Additional fees will be charged on the designated days off from school. Those days are not calculated into the charges applicable for full-time day care services.

### Program Extended Care Options

#### **Full Time AM and PM Care**

This care is for families who need to drop their children off before school in the morning between 7:00 a.m. – 7:40 a.m. and have the children stay after school in the afternoons five days per week.

#### **Full Time AM Care Only**

This care is for families who need to drop their children off before school 7:00 a.m. – 7:40 a.m. in the morning five days per week.

#### **Full Time PM Care Only**

This care is for families who need to have the children stay after school in the afternoons five days per week.

#### **Part Time AM and PM Care**

PT Care is for families who need less than five days of care, before and after school, for their children. The days needed are the same days each week. ( ie. M-T-Th or M-W-F). There is a three day minimum per child per week charge.

#### **Varied Time AM and/or PM**

Families who have extremely flexible schedules would use this care. Your children would attend less than five days per week but the days would vary from week to week or month to month. A minimum of one day notice is to be given to the SJS KidsCare Manager. There is a three day minimum per child per week charge.

Admittance to SJS KidsCare requires a weekly enrollment schedule of no less than 3 days per week. If you require childcare for less than 3 days per week, contact the KidsCare Manager or SJS Business Manager to discuss.

## SJS KidsCare Program 2017/2018 Fee Schedule

The school year at St. James/Seton Catholic School consists of 170 days over a 40 week period. The first week of school (3 days) and the last week of school (3 days) will be billed as early dismissal days. Regular billing periods for the extended care program will be for 34 weeks within the 40 week calendar period. Accounts are invoiced on Monday of each week during the school year and payment is due that week with the exception of the following weeks:

The week of August 21, 2017.

The week of Thanksgiving break.

The two weeks of Christmas break.

The week of Easter break.

The week of May 15, 2018

### Before-School Fee Schedule 7:00 – 7:40 a.m.

The fee for morning drop-off is \$20.00 per child weekly. If you are registered full-time (5 days/week) in the after-school program then the fee is \$10.00 per child weekly.

There is a non-refundable registration fee of \$50.00 per family due upon registration into the program.

The program allows for varied time/flexible schedules with a minimum of three days per week. Please contact the program manager to determine what the costs would be.

**Because of limited staff availability and state regulations for staff to student ratios, care is provided only on signed-up basis. Drop-ins will not be accepted.**
